Any corporation, partnership, joint venture or other business organization eligible for admission as a Regular Member, and whose average annual sales for the preceding three years do not exceed \$25 million. For purposes of this subsection, "sales" shall include sales made by (1) the organization; (2) any entity that owns more than fifty percent (50%) of the voting stock of the organization; and (3) any entity more than fifty percent (50%) of whose voting stock is owned by the organization.

Associate - \$2,000 annual dues

Any university, not-for-profit research institute, manufacturer or supplier of equipment, energy or services to the United States advanced ceramics industry not eligible for admission as a Regular Member.
